Non-Personal Information Collected by Website from Users.Â If you use our Website without registering, then the only information that we will collect from you will be certain non-personal information obtained through the use of Cookies or Web Beacons.Â

A.Â Â Â Â Â Â Cookies.Â A Cookie (also known as a Tracking Cookie, Browser Cookie, and HTTP Cookie) is a small piece of text stored on a user's computer by a web browser.Â

A Cookie consists of one or more name value pairs containing bits of information such as user preferences, shopping cart contents, the identifier for a server-based session or other data used by websites visited by the user.Â The information collected by Cookies helps us generate advertising, relevant content and direct newsletters for our users.Â The use of Cookies also allows us to statistically monitor the number of users to our site (â€œtrafficâ€•) and how many people open our emails. We may use Cookie information to target advertisements to users or to determine if a certain advertisement is popular or selected by our users.

B.Â Â Â Â Â Â Web Beacons.Â We also may

use a Web Beacon to collect non-personal information about our users. A Web Beacon (also known as a pixel tag or a clear GIF) is used in combination with Cookies, and is often used as a transparent graphic image that is placed on a website or in an e-mail that is used to monitor the behavior of the user visiting the website or sending an e-mail. When the HTML code for the Web beacon points to a website to retrieve the image, at the same time it can pass along information such as the IP address of the computer that retrieved the image, the time the Web beacon was viewed and for how long, the type of browser that retrieved the image and previously set Cookie values.

Web beacons are typically used by a third-party to monitor the activity of a website. A Web Beacon can be detected by viewing the source code of a Web page and looking for any IMG tags that load from a different server than the rest of the site. Turning off a browser's cookies can prevent some Web bugs from tracking a customer's specific activity. The Web site logs will still record a page request from the customer's IP address, but unique information associated with a cookie cannot be recorded. However, Web site server techniques that do not use cookies can be employed to help track a site's cookie-blocking users.

The information collected by Web Beacons allows us to statistically monitor how many people are using our site (â€œtrafficâ€•) and how many of our users are using or visiting the websites of our advertisers and sponsors. Web Beacons also helps us monitor how many people open our emails. ^ ^ ^

This Privacy Policy covers the use of Cookies and Web Beacons by our website only and does not cover the use of Cookies or Web Beacons used by any advertisers on our Website.
